CLUB GEAR REGULATIONS

These regulations have been prepared in line with the Club Constitution (Article 7.18), which grants the Executive Committee the power to, from time to time, make, alter and repeal Club regulations as they deem necessary, expedient, or convenient for the proper conduct and management of the Club.


The following regulations have been approved regarding the provision of playing gear.

Area	No.	Description of regulation
Club colours	1	The club colours ¹ shall be WHITE and BLUE . Please contact clubgear@stvincentsgaa.ie for details of our official blue colour, if required.
Club crest	2	The St Vincent's GAA Club crest ² shall be displayed on: <ul style="list-style-type: none"> - all match jerseys, shorts and skorts - all leisurewear 
Official Club match jersey	3	The official jersey of the Club is a white jersey with a horizontal blue band across the chest and a horizontal blue band around the sleeves at same level as the chest band. Where a sponsorship is in place, the sponsoring entity's logo will appear in the banded area across the chest. 
Official alternative Club match jersey	4	The alternative jersey is blue with a horizontal white band across the chest and a horizontal white band around the sleeves at the same level as the chest band. Where a sponsorship is in place, the sponsoring entity's logo will appear in the banded area across the chest. 
Ladies skort	5	The official skort of the Club for juvenile and adult camogie is a blue skort. 
Mens' shorts	6	The official shorts of the Club for juvenile and adult football and hurling is white shorts with blue vertical stripes. 
Ladies' shorts	7	The official shorts of the Club for juvenile and adult ladies' football is blue shorts with white vertical stripes.

Area	No.	Description of regulation
Socks	8	The official socks of the Club will be either long or short, white socks with blue hoops. 
Team Orders	9	ALL Club gear ³ must be ordered from the official club supplier (as selected by the Executive Committee ⁴). This is irrespective of: - whether gear is being used for fixtures or non-fixture activities; - whether it has a Vincent's crest or not; There are NO exceptions to this rule.
Individual Orders	10	Individuals shall order Club gear directly from the suppliers' online ⁵ site at. Please contact clubgear@stvincentsgaa.ie for their website details.
Club Gear Supplier	11	All team orders must be ordered via clubgear@stvincentsgaa.ie .
Support Irish Industry	12	In compliance with the rules of the GAA ⁶ , LGFA ⁷ and Camogie Association ⁸ , the Club shall use all practical endeavours to support Irish industry in relation to the provision of playing gear, equipment, and the provision of trophies.
Betting company sponsorship	13	In compliance with 1.17 (d) of the Official Guide, the Club shall abstain from engaging sponsorship (on club gear) from any company associated with betting.
Irish Manufacture	14	In compliance with article 1.18 of the GAA Official Guide, all jerseys, shorts, stockings, tracksuits (tops and bottoms) and kitbags, worn and/or used for official matches, in pre-match or post-match television or video interviews, player walk-ups and photographs, shall be of Irish manufacture.
Permission for Sponsorship deals	15	In compliance with 1.18 (d) the Club will not enter into a sponsorship agreement regarding the use of sponsor's brand name(s), distinctive marks or logo on playing gear unless it has obtained the prior written approval of the County Committee.
LGFA & Camogie Association	16	The Ladies Football and Camogie Associations rules specify that their association crest must be on match jerseys. To minimise cost, all Ladies team jerseys shall incorporate both Association crests.
